Victims Services Unit Strives to Empower Those It Serves

After a case is prosecuted and the defendant is placed on probation, what happens to the victim?

The court system, with its own language, acronyms, and procedures, can be a mysterious and forbidding place for crime victims. By design, the court system's focus is on the offenders, not victims.

Before 2015, probation officers often worked on a case-by-case basis to help victims and their families get their lives back together, drawing from a mix of informal networks as well as resources such as the Massachusetts Office for Victim Assistance (MOVA).

But since the creation in 2015 of the Victims Service Unit (VSU), a division of Massachusetts Probation Service, victims have a team of dedicated advocates embedded in the court system...

Solving the Identity Dilemma: OBTNs Offer Judges Access to Federal Criminal Case Records

What is an OBTN number and why is it important?

Fast, accurate access to federal criminal records. An Offense Based Tracking Number (OBTN) is a unique 13-character number assigned by a police agency to an arrestee for a specific arrest event. The Clerk's Office enters an OBTN at case initiation. The police can also provide an OBTN in an Electronic Application for Criminal Complaint (EACC) submission to the court.



An OBTN number connects an arrest incident to a fingerprint-supported state identification number (SID) managed by the Massachusetts State Police. OBTN and SID numbers only apply to criminal cases and should only be provided to the courts in instances where the defendant has been arrested and fingerprinted by the arresting agency...

In Your Mailbox: Judicial Evaluations for Barnstable, Bristol, Dukes and Nantucket Counties

What: If you work for the District Court, Housing Court, Juvenile Court, Probate and Family Court or Superior Court in Barnstable, Bristol, Dukes or Nantucket Counties, you can provide

feedback to the judges with whom you work by completing the Judicial Education Program evaluation. The evaluation process is completely anonymous. The judges will not see the questionnaire you submit.

When: You should have received a questionnaire at your home address. Please complete your evaluation and mail it back in the supplied postage-paid envelope as soon as possible.

Why: The scores you submit and the comments you write are taken seriously by the Trial Court. Each judge will meet with their department chief justice to discuss the evaluation and individual professional development plan. Your survey responses and comments help enhance the performance of judges and the judiciary as a whole. The evaluation program is the best way for you to tell the judge and department chief justice of your experiences working with these judges.
